

#### **30th Convocation Day**

Chaturvedi focused on the importance of Academic Excellence as well as strengthening the faculty, Advancement of Research and achieving International Accreditation from AACSB. He also extended his good wishes to all students of passing out batch who have successfully completed their Diploma Programme. A dazzling display of fireworks was a fitting end to an event signalling the transition from one phase of life to the next.



#### **International Conference on Management Cases 2017**

International Conference on Management Cases, ICMC 2017, a platform for academic and industry oriented research, international sharing and experiential learning was organized by BIMTECH, Greater Noida along with The School of Policy Government and International Affairs, George Mason University, Arlington, Virginia (USA) on November 30 and December 1, 2017.

In its seventh edition this year, ICMC 2017 had 61 cases collectively written by 93 authors which were presented over a period of two days. The conference was attended by 42 delegates from foreign countries. Largest contingent of 15 delegates participated from Finland followed by the USA. The Keynote speakers this year were Anna Maija Lamsa, Professor of Human Resource Management at the School of Business and Economics of Jyvaskyla University, Finland, and Phillip Charles Zerrillo, Dean of Postgraduate Professional Programmes at Singapore Management University (SMU).

Paying tribute to Late Prof. Sardana, who initiated ICMC, Dr. Chaturvedi in his speech emphasized the past success

and the future aspirations of ICMC. Among loud applause and much appreciation, Dr. Dey, Convenor of the conference announced the various awards. 10 case writers below the age of 40, were awarded the Dr. G D Sardana Memorial Young Scholar Award by BIMTECH. Apart from that, SAGE best Case Award was given to the case: "The story of Missing Middle: SAIF Partners and Aye Finance". Case Centre Best Case Awards were also announced. The case, "Patratu Vidyut Utpadan Nigam at Crossroads" bagged the first position, and the award for second position went to two cases respectively entitled, "Jaiprakash Associates Limited: Spurring Growth through Efficient Procurements", and "Influence of Store Atmospherics on Purchase Intentions".

The conference witnessed multiple sessions involving presentation of papers by distinguished research scholars on various thought provoking themes. All the selected cases were presented in three parallel sessions on various themes. ICMC 2017 witnessed an array of stimulating, original, case studies, in various facets of management. The conference indeed is a steady step towards strengthening the exploration of the importance of case studies in research and teaching.

The Case Analysis competition is an annual event and a permanent feature of BIMTECH. The students are exposed to real life problems and challenges which foster solution oriented skills and instilled change-maker attitude among them. The students also get an opportunity to display their analytical and presentation skills. By participating in the competition students develop Creative Thinking, Critical thinking skills, Solution-Oriented skills, Analytical Skills, Team-building Skills, Communication Skills as well as Presentation Skills. To encourage the participation and promote interest, the Centre for Management Case Development offers attractive cash prizes. The competition is conducted in a team of two students

In the preliminary round, they are given 90 minutes to go through the case, discuss with their partners and register their probable solutions on the power point slides. The teams in final round are expected to present the case in front of the jury members.

For ensuring the students right in getting quality education and also for ensuring that the society gets trained and ethical managers BIMTECH started AACSB journey in Year 2015.

Incidentally, the acronym AACSB stands for Association to Advance Collegiate Schools of Business. This is one of the three independent international accrediting agencies located in the USA.

AACSB's mission is to foster engagement, accelerate innovation, and amplify impact in business education. AACSB has accredited so far 800 of the world's best business schools across 100 countries and territories. In India they have accredited only 7 B-schools so far.

NBA, a highest national accrediting agency, under the Ministry of HRD, is an autonomous body, with the objective of Assurance of Quality and Relevance of Education, through the mechanism of accreditation of programs offered by the institutions. The process, parameters and criteria for accreditation are in line

with the best international practices and oriented to assess the outcomes of the programme. NAAC is an autonomous body established by the University Grants Commission (UGC) of India to assess and accredit institutions of higher education in the country. All the four PG programmes of the institute are accredited till 2022 by NBA. The programmes are also recognised by AIU that makes the PGDM diploma equivalent to MBA awarded by universities. In addition, National Assessment & Accreditation (NAAC) has also accredited BIMTECH with A+ grade.

In line with BIMTECH's commitment to offer high quality management programmes, it was decided, in the 2015, to go for AACSB accreditation. ## Workshop on Predictive Analytics with R

Centre for Research Studies (CRS), BIMTECH organised a workshop on "Predictive analytics with R" on September 2-3, 2017. The workshop was an attempt to empower the budding researchers, academicians and faculty the "R programming language". R is a user friendly and open source language, which has become a vehicle of choice for researchers to conduct data analysis. It is widely used among researchers for statistical analysis (linear and nonlinear modelling, classical statistical tests, time-series analysis, classification, clustering) and graphical presentation. It

is also utilized for data mining and text mining applications. The strengths of "R" are its well-designed publishing quality with mathematical symbols, formulae, organized documentation, high quality plots, designs and graphics. The workshop was an initiative by the CRS to facilitate the dissemination of knowledge of R for faculty and research scholars in their journey to conduct high quality research.

The workshop was conducted by two facilitators, Prof. Amarnath Bose and Prof. Amrendra Pandey both being faculty members of the Institute. The workshop attracted a mixture of participants from academia and

industry. There were 18 participants in total, out of which four were from industry, and the rest from academics including four research scholars.

#### **Research Committee Meeting**

The second Research Committee was held on February 14, 2018. The meeting was attended by the Director, Dean Research, who chaired the meeting, Chairperson CRS, two external members, three nominated members from BIMTECH, Area Heads of Economics, Operations and Decision sciences, Marketing and Finance and the member secretary of the research committee.

The committee discussed and approved the AACSB Assurance of Learning Plan and rubrics for assessment of the E/FPM Program learning goals. The committee also considered and approved the new plagiarism policy instituted by the Centre for Research Studies. The committee also provided valuable suggestions on the standard operating procedures for conducting various colloquia related to phase 2 (thesis work component of the program).

#### **Content Analysis Workshop**

Centre for Research Studies, BIMTECH organised the second Content Analysis Workshop on January 27-28, 2018 at the BIMTECH Campus in Greater Noida. The workshop was designed to provide training on a qualitative research tool called Content Analysis and acquaint the budding researchers, academicians, practitioners in management and faculty with qualitative methodology and tools to analyse the data using software like DICTION and HAMLET.

It was a two-day hands-on workshop which was facilitated by Prof. Srinath Jagannathan who is currently working as full time faculty in the Organizational Behavior and HRM department at IIM Indore.

Day 2 focused on developing contructs and dictionary with a focus on conjoint analysis with practical working on Hamlet and SPSS for performing content analysis.



- c. Business Process Innovation with IT,



#### **South Asian Journal of Business** and Management Cases

South Asian Journal of Business and Management Cases (SAJBMC), a peer reviewed, case focused journal is published by Sage with academic inputs from BIMTECH. In a short span of seven years it has made its impact felt among globally spread readers. Even though most of the cases are set in South Asian economies, more than 50% of downloads occur in USA, UK and Western Europe combined. With YOY increase of 24% the 12500 downloads in 2017 was more than many other case journals. Approximately 80% is paid downloads testifying the quality of the content.

After its indexing in SCOPUS and UGC the flow of good quality submissions has increased manifold. Currently, it is booked for more than one year. SAJBMC is one of the few reputed case journals that has OnLine First section giving authors more window for downloads before the issue comes out. Published two times in a year, each issue carries eight cases, half of these are set in countries outside India.

The 'guick turnaround' of desk review process and the 'review to improve' approach of reviewers for potentially good cases are two distinguishing features of SAJBMC which the authors found attractive.

Business Perspectives, a Bi-Annual Journal, provides a platform to scholars, researchers, practicing managers and academia to present their views, research findings and share their experiences.

For the last 17 years, Business Perspective has established itself as a fountainhead of knowledge and innovation in the area of business management.




#### **BIMTECH Shodh Gyaan**


#### "IT Strategy and Management" **Book by Prof Sanjiva Shankar Dubey**



#### **New Initiative**

A Committee drawn from among faculty was constituted to support the Chairperson, CFD in planning activities of the Centre. A decision to appoint a Manager for the Centre was taken and implemented.

#### **Performance Versus Target**

In 2017-2018, faculty participation was targeted at between 3-5 days in a year which the Centre achieved with faculty FDP attendance averaging 5.8 days during the year.

#### **Highlights of the Performance**

Dr Mahesh Sharma, Union Minister of State for Culture (Independent Charge). MoS - Environment Forest and Climate Change, and the Member of Parliament

from Greater Noida, had inaugurated the Atal Incubation Centre-BIMTECH, supported by the NITI Ayog under the Atal Innovation Mission, Government of India, on January 20, 2018. Atal Incubation Centre BIMTECH (AIC-BIMTECH) is one of a kind academia, industry and government partnership, driven under the Atal Innovation Mission to create high class incubation facilities with suitable infrastructure in terms of capital equipment and operating facilities. AIC- BIMTECH is accepting applications for 3 different stages i.e., Khoj (idea identification), Gurukul (building an MVP) and Udaan (scaling up of the company). It is coupled with the availability of sectoral experts for mentoring the startups so that startup businesses can become successful entrepreneurs and enterprises. 
The competitions conducted during the event were, "The B-Plan Competition",

#### **Summer Internships**




SECTOR-WISE SUMMER INTERNSHIP 2017-19 BATCH













#### 4th October-Violin Recital

#### **Cognicioun 2018**





The students interacts with CSR heads and field officers of the companies while visiting their CSR Project Intervention sites as well as with the gram pradhans, members of the community, school children, and targeted beneficiaries (of CSR projects of Companies).

During the academic year 2017-18, about 400 students visited 18 villages. The students interacted both formally and informally with various stakeholders of the company associated with their CSR projects of sanitation,



#### **NSCC: The National Sustainability Case Challenge**

National Sustainability Case Challenge was organized this year as a novel experiment. Undergraduate students from various parts of the country competed against each other spreading awareness on the various sustainability challenges of India. The participants were exposed to real life problems and challenges which fostered their solution oriented skills and instilled changemaker attitude among them. The campus round which was the final round was held on February 10, 2018. By participating in NSCC, contestants also could inculcate in them creative thinking, critical thinking skills, solutionoriented skills, analytical skills, teambuilding skills, communication skills as well as presentation Skills. The program spanned over two phases. The first phase witnessed around 169 teams register for the Case Study Challenge who were emailed a caselet which they had to analyse and suggest recommendations on the problem stated. Nearly 30 teams were shortlisted and were presented their final cases in phase two. The competition saw shortlisted teams from IIT BHU, Xaviers University Bhubaneswar, Chandigarh University, Miranda House, Jamia Milia Islamia, Shiv Nadar University, BITS Pilani and several other undergraduate colleges, who were invited to BIMTECH

to present their prepared presentations on the case.

BIMTECH's event partner for NSCC was United Nations Global Compact Network India who's Executive Director and CEO, Dr. Kamal Singh was the Honorable Chief Guest of the Case Study Challenge. NSCC's Media and Sustainability partner were the Civil Society and Governance Now respectively.


#### **NPTEL (The National Programme on Technology Enhanced Learning)**

Theses and dissertations are known to be the rich and unique source of information, often the only source of research work that does not find its way into various publication channels. Theses and dissertations remain an untapped and under-utilized asset, leading to unnecessary duplication and repetition that, in effect, is the antitheses of research and wastage of huge resources, both human and financial.

#### **Introduction of new Library Management Software: KOHA**

Although the BIMTECH Library is a fully computerized library, but to introduce new features and facilities the library had installed KOHA (Library Management Software). KOHA is a full featured integrated Library system. It is web based and has Web based online public access catalogue, which can be

accessed from anywhere through internet browser. Check-in, Checkout and Return reminders are sent to users. Users can search books, periodicals and other reading materials by author, title, subjects, ISBN etc. Its user friendly system allows saving your search history, reading history, make your own reading lists for future, place hold for books, give star ratings to books and other reading materials, write reviews and share on social networks sites. Users can also give purchase suggestions online to library.

The Installation of Linux Operating system (Ubuntu) on server, Installation & Configuration of KOHA (LMS), Email Server for sending notices, Customization of Web-OPAC & Staff interface, Data migration from excel and existing software New GenLib to KOHA (LMS) (59000 records approx.), Data migration of Parton's Data (1000approx.) had been done.

#### **Sustainable Project**

#### **Atal Incubation Centre**




