





Dr. Rajiv Kumar Vice Chairman, NITI Aayog

Dr. Rajiv Kumar took over as Vice Chairman NITI Aayog on September 1, 2017. He also serves as the Chancellor of Gokhale Institute of Politics and Economics, Pune. He was Principal Economist at Asian Development Bank, Manila where he spent 10 years. He has also served on many Boards including that of RBI and SBI. Dr. Kumar has a Ph.D. in Economics from Lucknow University and a D. Phil. From Oxford University.



## NITI AAYOG: STRATEGY FOR NEW INDIA @75

NOVEMBER 2018

n August 15, 2022, independent India will turn 75. In the lifespan of nations, India is still young. The best is surely yet to come. India's youthful and aspirational population deserves a rapid transformation of the economy, which can deliver double-digit growth, jobs and prosperity to all. A strong foundation has been laid in the last four years. While there is every room for confidence, there is none for complacency. A surge of energy, untiring effort and an unshakeable resolve on the part of the government, private sector and every individual citizen can achieve this transformation in the next five years.

Seventy years ago, similar energy, effort and resolve from all Indians freed the country from colonial rule within five years of the launch of the Quit India movement in 1942. Then, like now, foundations had been laid but a committed acceleration of effort was necessary. The Prime Minister's call for Sankalp Se Siddhi is a clarion call for a radical transformation for a New India by 2022-23.

The government has to be in the vanguard of the transformation of the Indian economy. However, the government's role must be defined correctly. This Strategy document attempts to do this. The document is being framed in a context where a re-imagination of governance is taking place. We need a 'development state' that focuses sharply on the difficult and accountable delivery of key public goods and services. There is an ongoing effort to achieve an optimum level of public-private partnership. Policies have been put in place for more efficient delivery of public goods and services such as health, education, power, urban water supply and connectivity. In this context, a deliberate effort is being made to cut red tape and end burdensome overregulation for promoting entrepreneurship and private investment. Also, in an effort to align the 'Strategy for New India @ 75' with India's commitment to the United Nations' Sustainable Development Goals, each chapter is mapped to the relevant goals. India is currently putting in place a 'development state' guided by the philosophy of Sabka Saath, Sabka Vikas.

The purpose of this document, 'Strategy for New India @ 75', is to define clear objectives for 2022-23 in a diverse range of 41 areas that recognize the progress already made; and challenges that remain; identify binding constraints in specific sectors; and suggest the way forward for achieving the stated objectives.

The Strategy document has disaggregated the 41 sectors under four sections: drivers, infrastructure, inclusion and governance. The first section on drivers focuses on the engines of economic performance — in microeconomic terms with chapters on growth and employment. The section also discusses strategies for the doubling of farmers' incomes; boosting Make in India; upgrading the science, technology and innovation eco-system; and promoting sunrise sectors like fintech and tourism. An annual rate of growth of 9 per cent by 2022-23 is essential for generating sufficient jobs and achieving prosperity for all. Four key steps, among others have been spelled out for achieving this GDP growth rate. These are:

- a. Increase the investment rate as measured by gross fixed capital formation (GFCF) from present 29 per cent to 36 per cent of GDP by 2022. About half of this increase must come from public investment which is slated to increase from 4 per cent to 7 per cent of GDR Government savings have to move into positive territory. This sharp increase in investment-to-GDP ratio will require significantly higher resource mobilization efforts as elaborated in the chapter on Growth.
- b. In agriculture, emphasis must shift to converting farmers to 'agripreneurs' by further expanding e-National Agriculture Markets (e-NAMs) and replacing the Agricultural Produce Marketing Committee (APMC) Act with the Agricultural Produce and Livestock Marketing (APLM) Act. The creation of a unified national market, a freer export regime and abolition of the Essential Commodities Act are essential for boosting agricultural growth.
- c. A strong push would be given to 'Zero Budget Natural Farming' (ZBNF) techniques that reduce costs, improve land quality and increase farmers' incomes. This is a tested method for putting environment carbon back into the land. Therefore, ZBNF allows India to significantly contribute to reducing the global carbon footprint.
- d. To ensure maximum employment creation, codification of labour laws must be completed and a massive effort must be made to upscale apprenticeships.

#### **Convocation 2019**

The second section on infrastructure deals with the physical foundations of growth. A lot of progress has been made across all infrastructure sectors. This is crucial to enhancing the competitiveness of Indian business as also ensuring the citizens' ease of living. Three key steps, among others, are:

- a. Expediting the establishment of the Rail Development Authority (RDA), which is already approved. RDA will advise or make informed decisions on an integrated, transparent and dynamic pricing mechanism for the railways. Investment in railways will be ramped up, including by monetising existing railway assets.
- b. The share of freight transported by coastal shipping and inland waterways will be doubled. Initially, viability gap funding will be provided until the infrastructure is fully developed. An IT-enabled platform would be developed for integrating different modes of transport and promoting multi-modal and digitised mobility.
- c. With the completion of the Bharat Net programme in 2019, all 2.5 lakh gram panchayats will be digitally connected. In the next phase the last mile connectivity to the individual villages will be completed. The aim will be to deliver all government services at the state, district, and gram panchayat level digitally by 2022-23, thereby eliminating the digital divide.
- The section on inclusion deals with the urgent task of investing in the capabilities of all of India's citizens. The three themes in this section revolve around the various dimensions of health, education and mainstreaming of traditionally marginalized sections of the population. While there are multiple dimensions and pathways contained in the chapters in this section, four key steps, among others, are:
- Successfully implementing the Ayushman Bharat programme including the establishment of 150,000 health and wellness centres across the country, and rolling out the Pradhan Mantri Jan Arogya Abhiyaan.
- b. Upgrading the quality of the school education system and skills, including the creation of a new innovation ecosystem at the ground level by establishing at least 10,000 Atal Tinkering Labs by 2020.

- c. As already done in rural areas, affordable housing in urban areas will be given a huge push to improve workers' living conditions and ensure equity while providing a strong impetus to economic growth.
- d. Implementing strategies to achieve regional equity by focusing on the North-East region and successfully rolling out the Aspirational Districts Programme.

The final section on governance delves deep into how the tasks/business of government can be streamlined and reformed to achieve better outcomes. It involves a sharp focus on ensuring accountability and a shift to performance-based evaluation. The government will revamp its data systems and analysis so that all policy interventions and decision-making are based on evidence and real-time data. This will yield efficient and targeted delivery of services and justice to those who need them the most. Three key steps, among others, are:

- a. Implementing the recommendations of the Second Administrative Reforms Commission as a prelude to appointing a successor for designing reforms in the changing context of emerging technologies and growing complexity of the economy.
- b. A new autonomous body, viz., the Arbitration Council of India, may be set up to grade arbitral institutions and accredit arbitrators to make the arbitration process cost effective and speedy, and to pre-empt the need for court intervention.
- c. The scope of Swachh Bharat Mission may be expanded to cover initiatives for landfills, plastic waste and municipal waste and generating wealth from waste.

To achieve the goals of New India in 2022-23, it is important for the private sector, civil society and even individuals to draw up their own strategies to complement and supplement the steps the government intends to take. With the available tools of 21st century technology, it should be possible to truly create a mass movement for development. With the Sanka/p of all Indians, India will have Siddhi. "



#### IN Conversation With Mr. Vikash Kandoi, Member, BOG, BIMTECH

"Let us be the creator of knowledge" says Mr. Vikash Kandoi, the successful industrialist from Kolkata and the prominent member of the Board of Governor of BIMTECH.



Mr. Vikash Kandoi has been involved with rechristening and reinventing brand "BIMTECH" since 2007. Having received his higher education in some of the best institutions of the country viz. St Xavier, Kolkata, IAI, New Delhi and ISB, Hyderabad, he has passionately contributed in improving quality of business education at BIMTECH. Mr. Vikas Kandoi has been appointed Honorary Council of Belgium in Kolkata by Belgium Ambassador to India, his Excellency Jan Luykx. In his life, he has been deeply inspired by late Smt. Sarala Birla and Syt. B K Birla, Founders & Patrons of BIMTECH.

Mr. Kandoi and his wife, Ms. Maitreyi Kandoi are also actively engaged in sports, fitness, wellbeing and CSR. Both of them are going to Everest Base Camp on April 6, 2019 for a two weeks' expedition. In this interview, Dr Baishali Mitra, Editor, Vrittant has asked questions about his journey as a member of the institute.

#### It is a privilege to be able to speak to you, Sir. You joined the Board of Governors of BIMTECH way back in 2007. During last one decade, what changes have you observed in the working of BIMTECH?

I had just got married at that time and I remember that Ma, Smt. Sarala Birla had asked me to visit BIMTECH to assess the situation and suggest improvement. At that time Mr. Jaju and Dr. Chaturvedi were there to lead the team. Ma was very happy with the report that I had submitted and they immediately wanted me to come on board. The only assurance they wanted from me was my time. I agreed and my relationship with BIMTECH began. From that time I have noticed that BIMTECH has had a steady progression and has transformed from an internally focused institute towards being global in its approach. Now, we have not national but a global perspective. Under the able leadership of Dr. Chaturvedi and his team there is an inherent desire among everyone to excel. If a leader can inspire to keep the fire in the belly ignited then there's absolutely no end and that team with its penchant for excellence can really take the institute to its height. There's enough freedom among the team.

Moreover, financial resources has never been a problem. It adds to keep up the motivation. I would be happy to mention over here that BIMTECH never requires any financial support. In-fact, it creates its own resources and has served as the mother of resources even for the Birla Global University. Whether it is creation of knowledge, which is most important, or creation of competent students, or creation of network with industry, liaising with political leaders and academia, BIMTECH is most steadily moving towards excellence.

There are lot of conversations both in the industry and academia about the future impact of the Industry 4.0 on higher education and particularly business education.

## What is your advice for our Institute? How should the Institute prepare itself to face this big change in the future?

Industry 4.0 has already been part of our deliberations during last few of our Board Meetings. We realize that we need to keep proper network in place so that we get the right knowledge well ahead in time. Our faculty is already armed with this knowledge not just to disseminate it to the students but also to be constantly updated by discussing with the industry. We have debated how well this should be integrated in our curriculum. So, BIMTECH is already equipped with this new knowledge. Education with the advent of internet is changing every year, and so you need to reinvent yourself. It's the job of the leadership to keep deliberating with the core team about what is happening in and around globally and realize what is relevant for our country and bring that on the table for our students. We need to be very careful about this constant change and internalize the same.

## Sir, your profile is indeed, exemplary. After Completing C.A., you have gone to ISB, Hyderabad for doing MBA. Since you were supposed to have become an entrepreneur, why did you devote time for getting two degrees from top notch institutions?

The question takes me way back in 1996 when I had passed out from school and Joined St Xavier's College, Kolkata. I lost my father at a very early age and I became the bread earner for my family. And so, I joined my family business at the age of 19. At that age when I was studying in St Xavier's College I realized that I had to arm myself with the strongest tool, called 'Knowledge' and ever since, that has been the only way I could survive in this ever changing interconnected world. It was no more the era of licenses or of having an exclusive knowledge about a specific field and capitalizing. That's why I decided to pursue C.A. while completing my Commerce





degree. After that as I was setting a couple of business here, the idea of joining ISB was formed in the mind and I went ahead. ISB gave me an opportunity of being able to come back to Kolkata every five or six weeks to organize things in my business and then to go back to the institute and study. So during that one year at ISB, I could come back to Kolkata almost 6 times to look after my business. It was kind of a joint role for me when I was pursuing my education as well as running my business. At the end of the day, it is all about putting in hard work in whatever one does, and completing my C.A. has been the toughest part but I am glad that I have acquired that knowledge.

## Besides managing your enterprise, you devote a lot of time on sports and physical fitness. We have heard that both you and your spouse, Ms. Maitreyi Kandoi, are going to the Everest Base Camp for 2 weeks' expedition. What motivates you to spare time for sports, physical fitness and for adventure sports?

Well, it's not about sparing time, it's about balancing one's life. Sports and physical fitness is as much a part of our life as business or knowledge or family togetherness is. So, it is an essential part of our life and we don't need to spare any extra time for it. Also, this is an inspiration that we have got from Syt. B. K. Birla and Smt. Sarla Birla. I still remember them outpacing me during morning walk easily, even when they were in eighties. They were into arts, into business, into philanthropy and everything was done to the perfect efficiency. So if one has such role models then one would automatically be inspired. We do these to maintain a healthy balance in life and to inspire our children.

#### What learning a leader can have from hobbies like sports, adventure, literature, arts and tourism?

It is very important to keep extending one's comfort zone. If one gets into a comfort zone then he or she stops growing or progressing. So we keep pushing ourselves and try different things. It helps us meet new people, it enables us inspire our children, it facilitates families to bond together. So it is important to balance one's life with various activities and it is never just about work. These holistic developments are essential for a leader to lead the path and that is exactly what can be traced in BIMTECH Legacy.

Kolkata as a city has an illustrious history for business, art, culture and cinema. Of late, it has lost its sheen as a business hub in spite of the fact that there are large number of family business enterprises. Do you think that Kolkata and its past glory can be reinvented in 21st century? How will it be possible?

First of all, my answer may sound a bit biased as Kolkata is my city and I am really fond of my city. Mittal is from this city. So I don't see the time as very far away when a lot of investments will come back to the city and I am very hopeful about it.

## BIMTECH has completed 31 years of its journey. What is your message to the alumni, current students and the faculty for taking it to new heights of excellence at national and global level?

Thirty One years for an Institute's journey is almost nothing. Our institute is meant for 200 years and more. So we are still at a nascent stage, at the stage of the foundation. We are fortunate to be a part of this foundation laying journey. So, the message is very strong, and very simple. I think let us not just consume knowledge. Let us be the creator of knowledge. Let us keep generating knowledge. It is human nature and so if we all come together and brainstorm we will create knowledge. In India, we are very efficient people, but when it comes to creation and that too knowledge creation, we are still behind. So we need to strive in those directions. Industry relevant research and impactful research is what is to be emphasized. So let us keep investing and the outcome will surely be satisfactory.



HELD ON FEBRUARY 27-28, 2019 AT NEW DELHI







#### **CONFERENCE HIGHLIGHTS:**

- The conclave had a thematic focus on 'Business Education 4.0: Futurizing Indian Business Schools'.
- Hon'ble Vice President of India, Shri Venkaiah Naidu was the Chief Guest and Prof. Eric Cornuel, Director General and CEO, European Foundation for Management Development (EFMD) was the Guest of Honour.
- Dr G Viswanathan, Founder & Chancellor, Vellore Institute of Technology (VIT), Dr H Chaturvedi, Director BIMTECH, Alternate President, Education Promotion Society for India (EPSI), and Dr M R Jayaram, Chairman, M S Ramaiah Group of Institutions were part of the sessions of the conclave.

cknowledging that the business education in India is standing at a cusp of change, hon'ble Vice President of India, Shri Venkaiah Naidu highlighted the need for public-private partnership (PPP) to promote quality education through innovation at the inauguration of the B-school Leadership Conclave at The Claridges, New Delhi, organised by EPSI supported by BIMTECH.

"We cannot depend on conventional teaching, we have to shift to innovative teaching pedagogies like case studies, simulations, open online courses such as MOOCs, use of technology like laptops and mobiles, and disruptive technologies such as AI in classrooms. Prof. Eric Cornuel, Director General and CEO, European Foundation for Management Development (EFMD) was the Guest of Honour at the inauguration where other dignitaries included Dr G Viswanathan, Founder & Chancellor, Vellore Institute of Technology (VIT), Dr H Chaturvedi, Alternate President, Education Promotion Society for India & Director BIMTECH, and Dr M R Jayaram, Chairman, Gokula Education Foundation were part of the inaugural session of the conclave.

"Business education today is more entwined with the world's socio-economic situation – globally, economic inequalities are on a rise and middleclass is rapidly shrinking; we need to ask if traditional education is enough to make the youth













employable," highlighted Prof. Eric Cornuel, Director General and CEO, European Foundation for Management Development (EFMD) in his address.

"Education is an important subject for any developing economy but unfortunately not for us. It is time now that we offer free education to all; we can start with free education to girls," said Dr G Viswanathan, Founder & Chancellor, Vellore Institute of Technology (VIT).

Speaking after releasing the book, Vice President Naidu said the focus of successive governments for the past many years has been to achieve "access, equity and excellence". Although substantial progress has been made over the years, a lot more needs to be done, particularly on the excellence front, he added.

Pointing out that quality assurance was important to improve higher education sector,

he said the root cause of the problem in private and government-funded institutions was commercialization and poor governance respectively. The true quality of education should be assessed by its ability to foster responsible citizenship and social cohesiveness, and inculcate moral and ethical values in students. This important aspect of quality education goes beyond the contours of the course curriculum and the actual teaching—learning processes that take place inside the classroom, he added.

Shri Naidu said that higher education transforms an individual into a responsible human being with social, moral and ethical values embedded in him or her apart from making the person more productive. Thus, quality assurance and accreditation mechanism should acknowledge the transformative role of education in a broader sense, he added.

The Vice President urged HEIs to accord greater importance to research and innovation and promote an eco-system for creativity to thrive. He said that having a research facility at Post Graduate College level should become a criterion for obtaining accreditation by bodies such as UGC (University Grants Commission) or NAAC (National Assessment and Accreditation Council).



Dr. H Chaturvedi's book, released by the Vice President contains articles, essays and research papers authored by some of the prominent educationists, policy makers, researchers and a media person, presents an analysis of the past and present scenario in the Indian Higher Education. The book also focuses on how to raise the quality of our colleges and universities to enable them compete globally.

Higher Education in India, has been a significant contributor to the evolution of human civilisation and consciousness. At a global level, higher education has played a significant role during the last three centuries in creating a global community of nations and as an harbinger of era of renaissance, facilitating three major industrial revolutions.

Following global trends, India's higher education system has been a game changer in the making of India as a modern nation, a dynamic society and a global economic power. It has opened the doors of universities and colleges to all sections of society, particularly young men and women from the under privileged sections of our society. The twentieth century has witnessed great churn in society when the children of poor and oppressed families could rise in the social ladder, due to their access to colleges and universities as students.

A very fast expansion of the Indian Higher Education sector has been a recent phenomenon of hardly the last 2-3 decades. At the global level, due to its size and expanse, India is ranked

second after China. Though our current Gross Enrolment Ratio (GER) is 25.2 percent, it lags behind the global average of 33 percent and that of emerging economies, such as Brazil (46 percent), Russia (78 percent), and China (30 percent). To address this concern, the Government of India has been working on achieving three key strategic objectives viz., 'access, equity and excellence'. There have been substantial improvement in achieving the first two objectives i.e. access and equity. The third objective of excellence (quality) has now occupied centre stage.

# RESEARCH WORKSHOP RESOURCE PERSON: Dr. Anol Bhattacharjee







Anol Bhattacharjee is a full professor of information systems and the Exide Professor of Business Ethics at the University of South Florida. His research focuses on a broad range of topics related to healthcare informatics, crowdsourcing of innovations, dysfunctional consequences of technology use, and machine learning biases. He teaches classes on statistical data modeling, research methods, and design of innovations. In a research career spanning 22 years, Bhattacharjee has published more than 65 refereed journal papers that have received more than 18,000 citations on Google Scholar. He has authored a free textbook on research methods called "Social Science Research: Principles, Methods, and Practices" that has been downloaded more than 625,000 times, used in 216 countries on six continents, and is available in seven languages.

Anol was the principal investigator in U.S. federal grants exceeding \$750,000. He served on the editorial boards of MIS Quarterly and the Journal of the AIS. He is the current Fulbright-Nehru Distinguished Chair, funded by the US Department of State and the Government of India, with a visiting professor appointment at Indian Institute of Technology, Kanpur for Spring 2019.

# कालिंजर दुर्ग (बुंदेलखंड, उत्तर प्रदेश): अनेकों युद्धों का प्रत्यक्ष गवाह तथा नीलकंठ महादेव का अनोखा मंदिर



विश्व के प्राचीनतम किलो में शुमार विंध्य की पहाड़ी पर 700 फीट ऊंचाई पर स्थित यह किला अनेक युद्धों का प्रत्यक्ष गवाह है। आरंभ में यह स्थान तीर्थ रूप में था किंतु दुर्ग के लिए भी उपयुक्त था। इस किले की वास्तविकता आज भी रहस्य है, कुछ इतिहासकारों का कहना है कि इसका निर्माण बर्गुजर राजाओ नें 150 से 250 ई. के मध्य करवाया था। दुर्ग में प्रवेश के लिए सात दरवाजे हैं। यहाँ कई तरह की गुफाएँ हैं, जिनका ओर तो है लेकिन छोर नहीं, जिनका इस्तेमाल सीमाओं की हिफाजत के लिए होता था। किले में मौजूद रानी महल में, एक दौर था जब महफिलें सजा करती थीं। कहते हैं कि आज 1500 साल बाद भी शाम ढलते ही एक नर्तकी के कदम यहां थिरकने लगते हैं, फर्क यह है कि अब इन घूंघरओं की आवाज दिल बहलाती नहीं बल्कि दिल दहला जाती है!

रणनीतिक दृष्टि से देखा जाय तो दुर्ग की पृष्ठभूमि ढेरों युद्धों एवं आक्रमणों से भरी पड़ी है। विभिन्न राजवंशों के हिन्दू तथा मुस्लिम शासकों द्वारा इस पर बड़े आक्रमण हुए, किन्तु चन्देलों के अलावा कोई भी लम्बा नहीं टिका। इसकी सुरक्षा प्राचीर की परिधि लगभग 6 किमी है। ऐतिहासिक एवं धार्मिक दृष्टि से देखा जाय तो यहाँ गुप्त काल से लेकर मध्य काल के अभिलेख है, हजारों नष्ट-भ्रष्ट एवं ग्रेनाइट तथा बलुआ पत्थर की खण्डित मूर्तियां हैं। किले के अंदर धार्मिक मूर्तियों का दुर्लभ भंडार है जो झाँसी से लेकर खजुराहो तक के म्यूजियमों की शोभा बढा रहा है। प्राचीन स्मारक सुरक्षा कानून 1905 में बना था, तभी से पूरा दुर्ग और मूर्तियां सुरक्षित घोषित कर दी गई थीं। 100 सालों से अधिक समय से शिल्प-संग्रह का यह भंडार बुन्देल शासक छत्रसाल के वंशज अमान सिंह द्वारा बनवाये अमान सिंह महल में सुरक्षित है। दुर्ग एवं इसके नीचे तलहटी में बसा कस्बा, दोनों ही इतिहासकारों की दृष्टि से महत्त्वपूर्ण हैं, क्योंकि यहाँ मन्दिरों के अवशेष, मूर्तियां, शिलालेख एवं गुफाएं, आदि सभी उनके रुचि के साधन हैं। कालिंजर दुर्ग में कोटि तीर्थ के निकट लगभग 20 हजार वर्ष पुरानी शंख लिपि स्थित है जिसमें वनवास के समय भगवान राम के कालिंजर आगमन का भी उल्लेख किया गया है। इसके अनुसार श्रीराम, सीता कुंड के पास सीता सेज में ठहरे थे। किले में कई आकर्षण है जिनमें अलग अलग कई महल, मंदिर, तालाब और वन हैं। तालाबों के जल को औषधीय गुणों से भरपूर माना जाता है। मान्यता है कि चंदेल राजा कीर्तिवर्मन का कुछ रोग भी यहीं स्नान करने से दूर हुआ था।

नीलकंठ मंदिर व किले तक जाने वाले मार्ग पर भारतीय पुरातत्व सर्वेक्षण विभाग की टिकट चौकियां हैं। पहले प्रवेश निःशुल्क था, किन्तु 2015 से प्रवेश शुल्क है। इसका उद्देश्य दुर्ग के अनुरक्षण हेतु निधि जुटाने के साथ साथ आवारा जानवरों एवं असामाजिक तत्वों पर रोक लगाना भी है।

हजारों साल पुराने इस किले का इतिहास ही कुछ ऐसा है कि लोग इन वीरान खंड्हरों की ओर खिंचे चले आते हैं। ये जगह कुछ है ही ऐसी जहां पंहुच कर आपको स्वतः ही ऐतिहासिकता तथा रोमांचकता का अहसास होने लगता है। किले के इतिहास से अलग लोगों को ज्यादा दिलचस्पी है छुपे खजाने में। किले ने अब तक जितनी भी लड़ाइयां झेली वो सब खजाने को लेकर ही हुई। माना जाता है कि कालिंजर किले में प्राचीन काल से ही हीरे-जवाहरातों का जखीरा है। यहाँ के स्तंभों एवं दीवारों में कई प्रतिलिपियां हैं जिसमें यहाँ छुपे हुए खजाने की जगह का रहस्य भी छुपा है। दरअसल ये दुर्ग पहाड़ी नहीं अपितु एक लम्बी चौड़ी पहाड़ी को चारों तरफ से घेर कर, उंची और मोटी दीवारों से सुसज्जित कर पूरी पहाड़ी को ही एक दुर्ग का रूप दे दिया है। महात्मा बुद्ध के समय यहाँ चेदि वंश का आधिपत्य रहा, बुद्ध की यात्रा वर्णन में उनके कालिंजर आने का उल्लेख है। इसके बाद यह मौर्य साम्राज्य के अधीन आ गया, तत्पश्चात् शुंग वंश तथा कुछ वर्ष

पाण्डुवंशियों का आधिपत्य रहा। इनके बाद यह वर्धन साम्राज्य के अधीन भी रहा। गुर्जर प्रतिहारों के शासन में यह उनके अधिकार में आया एवं नागभट्ट द्वितीय के समय तक रहा। 249 ई. में यहाँ हैहय वंशी कृष्णराज का शासन था, एवं चतुर्थ शताब्दी में नागों का अधिकार हुआ, जिन्होंने यहाँ नीलकंठ महादेव का मन्दिर बनवाया। तत्पश्चात् सत्ता गुप्त वंश को हस्तांतरित हुई।

शेरशाह शूरी ने नवम्बर, 1544 में कालिंजर पर आक्रमण कर दिया, दुर्ग पर घेरा एक साल तक रहा, दोनो तरफ से भयानक युद्ध हुआ किन्तु दुर्ग पर शेरशाह का अधिकार नहीं हो पाया। अंत में मामला हाथ से निकलते देख शेरशाह ने दुर्ग को बारूद से उड़ाने का निश्चय किया। 22 मई, 1545 को किले पर तोपों से गोले दागने शुरु किये गये, इसी दौरान शेरशाह के बारूदखाने में भयानक आग लग गयी जिससे शेरशाह बुरी तरह जल गया, फिर भी दुर्ग पर कढब्जे की लालसा से उसने दुर्ग पर आक्रमण जारी रखने की आज्ञा दी। आखिरकार, ये युद्ध और कढिला तो जीत लिया गया लेकिन शेरशाह मौत से युद्ध हार गया तथा कढिले पर शासन् करने का उसका सपना, सपना ही रह गया! तदुपरांत इस कढिले पर राजपूतों ने अपना प्रभुत्व कढायम कर लिया।

1569 ई. अकबर ने मजनू खढाँ को किढले पर आक्रमण के लिए भेजा, परंतु राजा रामचन्द्र ने बिना विरोध के किढला मुगलों को सौंप दिया। इसके बाद कालिंजर किला राजा छत्रसाल के अधीन हो गया और फिर इस पर पन्ना के राजा हरदेव शाह ने शासन किया तथा मान्धाता चौबे को कालिंजर का दुर्गपित नियुक्त किया। 1812 में ब्रिटिश सेना ने बुंदेलखंड पर आक्रमण किया, कर्नल मार्टिन्डेल ने चौबे परिवार को दुर्ग से बेदखल कर अपने अधिकार में ले लिया। इसके बाद अंग्रेजों ने कालिंजर को बाँदा जनपद में सम्मिलित कर दुर्ग को सैनिक छावनी में बदल दिया।

कालिंजर अर्थात समय का विनाशक कालः अर्थात समय, एवं जरः अर्थात विनाश। मान्यताओं के अनुसार सागर मन्थन उपरान्त भगवान शिव ने विष का पान कर अपने कण्ठ में ही रोक लिया जिससे उनका कण्ठ नीला हो गया। तब वे कालिंजर आये व काल पर विजय प्राप्त की. तभी से कालिंजर स्थित शिव मन्दिर को नीलकंठ कहते हैं। कालिंजर किला भगवान शिव का निवास माना जाता है, यहां नीलकंठ महादेव का अनोखा मंदिर हैं जिसका निर्माण नागों (नागवंशियों) ने कराया था, मंदिर का जिक्र पूराणों में है। मंदिर में नीले रंग का स्वयंभू शिवलिंग स्थापित है। यहाँ पर्वत काटकर बनाई गई कालभैरव की विशाल प्रतिमा है जिसके बगल में चट्टान काटकर जलाशय बनाया गया है जो पहाड़ से ढका है। वक्ष में नरमुंड और त्रिनेत्र धारण किए यह प्रतिमा बेहद जीवंत है। काल भैरव को भगवान शिव का रौद्र रूप माना जाता है। यह एक झूलता हुआ मंदिर प्रतीत होता है, जब आप यहाँ पर खड़े होते हैं तो लगता है मानो आप सैकड़ों फीट उंची किसी इमारत की सैकडों फीट उंची बालकनी के बाहर झांक रहे हैं। मंदिर के 170 सीढी उपर किंदले की मबजूत दीवार और नीचे जंगल। चन्देलों के समय से ही यहां पूजा अर्चना ब्राहम्ण नही बल्कि राजपूत करते हैं। ऐसा शायद यहाँ होते रहे युद्धों को देख कर किया होगा! प्रवेशद्वार के दोनों ही ओर ढेरों देवी-देवताओं की मूर्तियां दीवारों पर तराशी गयी हैं। महाकाव्यों, पुराणों और अन्य प्राचीन संस्कृत ग्रन्थों में कालिंजर को शैव साधना का एक महत्तवपूर्ण केन्द्र स्वीकारा गया है।

कालिंजर दुर्ग अभी भी पर्यटन नक्शे पर उस प्राथमिकता में शामिल नहीं है, जैसा कि उसे होना चाहिए। एक बार युनेस्को की इस सूची में कालिंजर के जुड़ जाने पर यह स्थल विश्व के पर्यटन मानचित्र में जुड़ जाएगा।
