b) A Maruti Swift private car purchased on 27th June, 2011 is insured under a package policy for period 6-09-2015 to 5-09-2016, met with an accident on 14-11-2015 at Udaipur The insured raised a claim of Rs 215977 The vehicle was surveyed on 24-11-2015 at M/S. Shri Krishna Autosales Pvt. Ltd., (9) Udaipur.

Contd-3/-

As explained by the insured in claim form that while coming from Balesar a ongoing Tata Indigo applied sudden brakes which driver of Swift car could not control and dashed into ahead going Tata Indigo from Rear and simultaneously a trolla banged at Rear causing damages.

The accident impacted heavily at front. Front bumper broken and dislocated by breaking its all mountings; linings and holders (brackets). Air cleaner assy; fan assy; Radiator & grills assy; Horn assy; switch assy L&T; LH/RH head lamp assy and fog lamp assy both broken. Front bulk head all three members impacted bent and misaligned. Hood crushed, bent, twisted and deformed, its both hinges bent and misaligned. RH fender crushed and deformed but LH fender only pressed, its both fender linings cut and sheared. Windshield glass broken. Condenser and Intercooler all three impacted crushed and deformed, its core pipes cut and sheared (hose discharge).

Remaining all the assys and sub assys found intact and safe. The details of the estimate are as under:
